

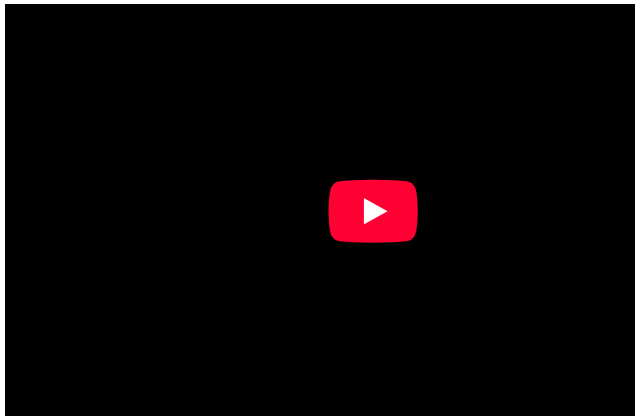
## World Post Day 2019
